AN ORDINANCE OF THE CITY OF SHADY COVE, OREGON, AMENDING THE SHADY COVE COMPREHENSIVE PLAN AND THE AIRPARK COMMERCIAL CHAPTER OF THE SHADY COVE CODE OF ORDINANCES

WHEREAS, Chapter 154 of the Shady Cove Code of Ordinances governs Type IV Legislative Procedures within the corporate limits of the City and requires, if approval is recommended by the Planning Commission, that the City Council of the City of Shady Cove make the final decision regarding the application; and,

WHEREAS, The Shady Cove Planning Commission, after providing proper public notice, met in Public Hearing on September 22, 2016, to consider amendments to the Shady Cove Comprehensive Plan and Shady Cove Code of Ordinances to include revisions to the Airpark Commercial zone. The draft Comprehensive Plan elements are attached as Exhibit A; the draft amendment to the Code of Ordinances is attached as Exhibit B. The Commission received testimony from interested parties and staff. The staff recommendations, as submitted to the Planning Commission, are contained in a staff report that is part of the record; and,

WHEREAS, On September 22, 2016, following the close of the public hearing, the Planning Commission deliberated on the record of the proceedings, after which a motion was made and duly seconded, to recommend that the City Council approve Planning File No. CPA 16-01. The motion passed by a roll call vote of 4 to 0; and,

WHEREAS, On October 20, 2016, the City Council held a public hearing; and,

WHEREAS the City Council deliberated on the record of the proceedings, after which a motion was made and duly seconded, to approve Planning File No. CPA 16-01.

THE COUNCIL OF THE CITY OF SHADY COVE ORDAINS AS FOLLOWS:

The Shady Cove Code of Ordinances is amended as follows:

Section 1: Title This Ordinance shall be known as the 2016 Comprehensive

Plan and Revised Airpark Commercial District.

Section 2: Description Revised Comprehensive Plan, attached as Exhibit A; revised

Airpark Commercial District Section 154.121, attached as

Exhibit B, approved by the City Council.

Section 3: Amendment

The Shady Cove Comprehensive Plan is replaced in its entirety; the permitted use regulations contained in Chapter 154.121 of the Shady Cove Code of Ordinances Plan Map are amended to included required elements of Oregon Revised Statute 836.616.

Section 4: The City Council adopts as its own, and incorporates by reference, the Planning Commission recommendation attached as Exhibit C.
