## **FINANCIAL MATTERS**

Financial tracking through February reflects:

- General: Revenue exceeding budget, expenses a hair under budget.
- Street: Revenue exceeding budget, again expenses slightly under budget.
- Sewer Operations: Revenue exceeding budget, expenses in excess of budget, but is a factor of contract payment timing. March results will reflect expenses consistent with budget.

Staff continues to do an excellent job managing finances.

## **CITY COUNCIL MEETING: MARCH 3, 2016**

The City Council had no action items on their agenda for this meeting.

Mike Cavallaro, Executive Director of the Rogue Valley Council of Governments, provided the Council with an annual overview of the organization, their primary activities and accomplishments as well as services provided to Shady Cove.

Interactively with the Council, Jackson County Sheriff's Deputy Jeff McGrath spoke about public safety matters as well as his interaction with the community at large. He also reiterated his commitment to serve at least 2 years in Shady Cove which greatly pleased the entire Council.

Two applicants applied for the vacant positions on the City's Budget Committee: Dick McGregor and Ed Mayer. Both are or have been directly involved in City/County Government and or have extensive business experience. They were appointed to fill the two vacancies.

## **CITY COUNCIL MEETING: MARCH 17, 2016**

*... continued*

The Council reviewed the submissions, by two Engineering Firms, to provide a long term assessment of the Wastewater Treatment Plant. They are:

Dyer Partnership Engineers & Planners, Inc.	\$29,500
Civil West Engineering Services, Inc.	\$20,918

The Council expressed concerns regarding the detail and quality contained in each submission. Following considerable discussion, it was concluded that Civil West Engineering Services, Inc. would provide the information desired by the City and are locally available for meetings at the plant or additional sessions with Staff or Council.

Ultimately, the Council authorized the City Administrator to enter into an agreement with Civil West Engineering Services, Inc.

It is anticipated that the assessment will provide the current as well as future administrations sufficient information to accurately and timely plan, schedule and budget upgrades and or equipment replacements.

The Council approved a motion to allow the City Administrator to approve or deny OLCC permit requests. Applicants can appeal decisions to the City Council.
